

Lantau Island Tour with Seafood Lunch

Pick up from hotel approx. 0900 and transfer to Tung Chung for the cable car to Ngong Ping. Ngong Ping Cable Car is a unique world class tourist attraction with 5.7km in length and 112 cabins. Explore the new Ngong Ping Cable Car to get a 360° panoramic view of Lantau Island including Tian Tan Big Buddha, the flora and fauna of North Lantau Country Park, Tung Chung Bay and the Hong Kong International Airport.

Your tour includes the Ngong Ping Village where all the buildings are architecturally designed to reflect and maintain the cultural and spiritual integrity of the Ngong Ping area, and the Po Lin Monastery. Known as the “Buddhist Kingdom in the South”, Hong Kong's Po Lin Monastery is the most popular Buddhist temple in Hong Kong. The Monastery oversees the giant bronze statue of the Sakyamuni Buddha.

Take the cable car down to Tung Chung town centre after the tour, and transfer to Lei Yue Mun Seafood Village for lunch.
